4. Carry out a Competency Check with a Gr I, Gr II Flight instructor or DFE.
5. Certified copies of (a) valid foreign license, (b) valid foreign medical, (c) valid passport.
6. Copy of logbook (last three pages – inclusive of competency check endorsement).
7. Application fee as per Part 187.
